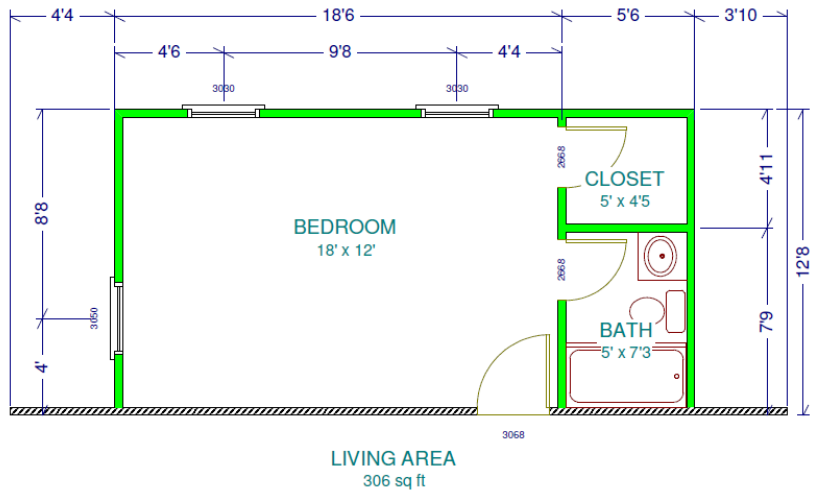

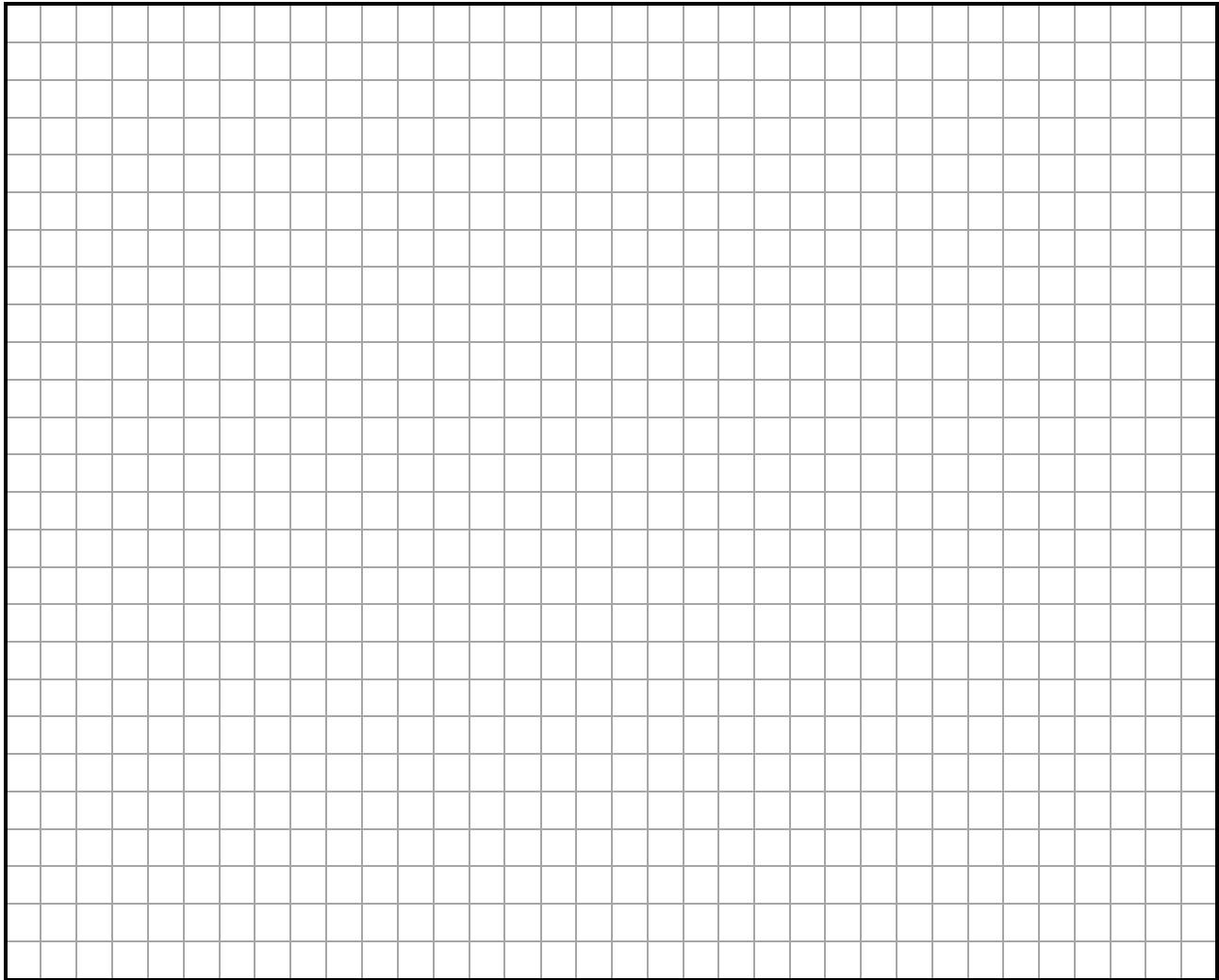

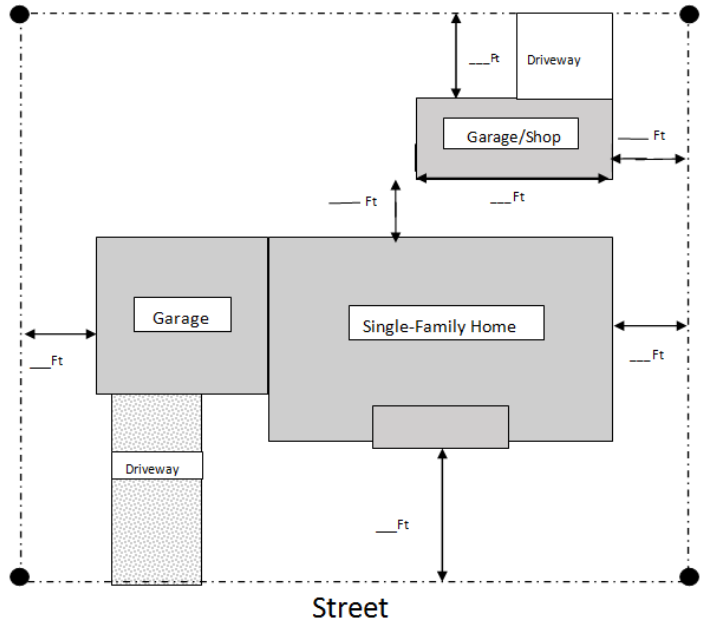

No structure shall be allowed to be constructed within any public utility and drainage easement. In general there is an easement 10' in width on all front and rear property lines, and 5' in width on all side lot lines. In some instances these can vary, and will be described in the property deed, and shown on the final plat of the subdivision. Additional permits may be required for site construction.
