WHENEVER THE NUMBER OF CABS SO OPERATED SHALL BE INCREASED DURING THE LICENSE YEAR, THE LICENSEE SHALL NOTIFY THE RECORDER OF SUCH CHANGE AND SHALL PAY THE ADDITIONAL FEE.

THE LICENSE OF ANY LICENSEE SHALL BE SURRENDERED WHEN SUCH LICENSEE CEASES TO TO DO BUSINESS AS A TAXICAB BUSINESS. NO LICENSE MAY BE TRANSFERRED BY ANY LICENSEE TO ANOTHER PERSON
