1. Development agreements and performance sureties shall be signed, submitted, and in correct form at the Resubmittal date for final plats.
2. Required improvements including binder and curbing shall be completed prior to the Resubmittal date for final plats
3. All submittals and resubmittals shall contain all documents. Only the documents contained in each submittal/resubmittal shall be considered for the item. Previously submitted documents shall not be considered.
4. Items not complete after Resubmittal shall not be added to the CMPC Agenda. Those items shall be considered on the following month's CMPC agenda and associated deadlines including Technical Committee and Resubmittal.
5. Items not complete after a second Resubmittal shall be deemed incomplete and a new application and fee must be submitted for further consideration.
6. Applicants shall schedule and attend a Concept Meeting prior to or on the deadline listed. Applicants shall submit a concept plan prior to scheduling a concept meeting.
